Chiefly due to the advent of the report of excellent progress in New York State, the two-year percentage of gain moves up another 2 1/2 points to 39 3/4 per cent. The ten-year percentage goes up 41 1/2 points to 369 3/4 per cent.

The twelve states yet unreported appropriated a total of \$2,360,032,000 for the prior fiscal year, 1969-70. If their appropriations for 1970-71 only equal those for 1969-70, then the fifty-state total would be about \$6.7 billion. If the twelve states make average gains of 20 per cent over the one year preceding fiscal year 1970-71, then the fifty-state total would be \$7.1 billion. It is probably safe to predict that the final fifty-state total for 1970-71 will be \$7 billion.

The total for fiscal year 1970-71 appears to be a gain of 51 per cent over the figure for fiscal year 1968-69, two years earlier.

The ten-year gain since fiscal year 1960-61 is 414 per cent.

There was a capital outlay appropriation of \$15,178,000, of which \$12 million went to the three universities; slightly over \$3 million to the junior colleges.

MAINE. Under date of December 18, 1969, the Board of Trustees of the University of Maine has issued a 9-page Report, which it calls "the initial part of a master plan."

It will be recalled that under a statute of 1968 the University now embraces its former units at Orono, Portland, and elsewhere, plus the five former state colleges at Gorham, Farmington, Aroostook, Washington, and Fort Kent. It does not include the Maine Maritime Academy or the vocational-technical institutes.

The board says the appropriation of about \$22 1/4 million of state tax funds for operating expenses of the University for fiscal year 1969-70 was about \$1,600 per full-time student. It projects an inflation factor of 7 to 8 per cent per year, and says "for each additional full-time student public support should provide about \$1,600 a year compounded by a possible 7 to 8 per cent increase annually."

Among the aims enunciated:
(1) Development of a community college network (programs of one and two years) in population concentrations where there are no public higher educational opportunities in the vicinity; campuses at Bangor and Augusta to be the first units.

- (2) Closer liaison with the State Board of Education and its vocational-technical schools.
- (3) As of July 1, 1970 the University of Maine in Portland and the School of Law be detached from the jurisdiction of the Orono campus and consolidated with Gorham State College to form a new unit to be styled the University of Maine, Portland-Gorham. "Full implementation" of this scheme has target date of July 1, 1971.
- (4) The state colleges at Fort Kent and Washington to continue as four-year campuses of the University,

- (5) The state colleges at Aroostook and Farmington to continue as four-year campuses for teachereducation, and add "strong liberal arts programs towards eventually granting a liberal arts degree."
- (6) Development of two graduate centers (at Orono and Gorham-Portland); the Orono campus to be the flagship and exemplar, providing leadership and assistance in the development of the other campuses, "because of its resources in faculty and equipment, experience and tradition."
